#### **General Rules for Documentary Operations:**

Fees of correspondent banks are not included.

SWIFT message fee for documentary operations is EUR 10/equivalent.

For services involving a courier charge, the fees are LEI 20 and for post mail and EUR 50 for urgent carrier (fee paid upon collection, VAT included). For debit instruments collection services that implies courier taxes, commissions will be 15 lei/transport.

In the case of Letters of Guarantee, the mortgage on receivables applies only to guarantees based on contracts that will generate revenue for ProCredit Bank's clients; if such contracts do not exist, the commission is charged at the level at which the mortgage on receivables would exist.

## Other Fees Related to the Lending Activity
